THE PROJECT:

The Chesapeake Bay Foundation is seeking a contractor to replace the roofing on 7 of our buildings at Clagett Farm located in Upper Marlboro, MD. Each roof is noted below with approximate building sizes. Contractors may bid on roofs individually. If submitting a bid for all projects, the cost must be noted for each roof individually. It is required that each roof receives, at a minimum, a 20-year, no-dollar limit warranty. Due to the uniqueness of the buildings and property, a site visit is encouraged and will be arranged upon request.

SCOPE OF WORK:

1. Replacement of Cedar shake roofing on historic Icehouse. 20'x20'
2. Replacement of Cedar shake roofing on historic Well House. 8'x6'
3. Replacement of Cedar shake roofing on historic Smoke House. 16'x 25'
4. Replacement of asphalt roofing on Cottage Garage. 32' x 22'
5. Replacement of asphalt roofing on Upper Tool Shed. 21' x 24'
6. Replacement of asphalt roofing on Equipment Shed. 20' x 62'
7. Replacement of asphalt roofing on ½ of Middle Barn. 22' x 80'

THE SCHEDULE:

We request that your proposal be delivered electronically to CBF staff member Dom DiMarco (ddimarco@cbf.org) no later than 5:00pm on 11/22/23.

It is the intent of CBF to select no later than 12/13/23. We will notify you once a decision for award of bid is made.

The schedule requires that the selected entity complete the project by 1/1/24.

MINIMUM REQUIREMENTS:

At a minimum, you must be able to provide the following:

- An active MHIC number
- General liability and workers compensation insurance certificate

INTERVIEWS:

Interviews will not be necessary.
